Hereby undertakes to:

Ensure responsibly the welfare of the aforementioned minors from the moment they enter the venue, to remain with them throughout the whole show and, once finished this one, to leave the venue with the them.

Ensure that the identification of minors is possible at all times, by the security staff of the venue or the police, guaranteeing the visibility of the appropriate badge.

Prevent the consumption, by minors, of alcoholic drinks, tobacco, and narcotics.

Avoid any situation that could pose a risk or danger to minors, likewise he/she will be responsible for any attitude of the minors, which could suppose a risk for themselves or for third parties, exempting the organization of any responsibility if any of these circumstances occurred.

Failure to sign this document or failure to comply with any of its conditions may result in the cancellation of the ticket or expulsion from the venue, without the right to a refund of the amount. In the same way, the presumption by any member of the security staff of the venue that any of these conditions may be violated, or circumstances that pose physical risk or inappropriate content for the minors, will be sufficient reason to consider the cancellation of the ticket.
